Art competition in celebration of the Day of German Unity 2025

Terms and Conditions:

1. The competition is open to young people aged **15–23 years**, who are **residents of Kenya**.
2. **Participation is free** of charge.
3. Each entrant may submit **only one artwork**.
4. Submissions must be **received by 11:59 pm (EAT) on 30 June 2025**.
5. The artwork can be any form of **two- or three-dimensional artistic expression**, including but not limited to painting, drawing, etching, sculpture, assemblage, montage, collage, photograph, music composition, installation, or video.
6. For selection purposes, participants must submit **clear, detailed images or recordings** of their artwork (total file size not exceeding 3 MB), or a **download link** to these files, via email to bomoaukuta@nair.diplo.de.
7. **Do not send original artworks** at this stage. Finalists will be contacted with delivery instructions.
8. Submitted artworks must be based on the theme **#BomoaUkuta** (see www.nairobi.diplo.de/bomoaukuta).
9. To be eligible for exhibition, artworks must not exceed **100 x 100 x 70 cm** in dimension and **7 kg** in weight.
10. Entries must be the **original work** of the participant and must not have been previously published or exhibited.
11. All submitted work must **not infringe** on any copyrights, trademarks, or personal rights. Participants are solely responsible for any such issues.
12. Participants must have **consent from all individuals involved** in any artwork (e.g. identifiable subjects in photos, performers in videos/music).
13. The Promoter (German Embassy Nairobi) is **not liable** for any legal claims or copyright violations arising from the submitted works.
14. Participants grant the Promoter a **non-exclusive, royalty-free license** to use submitted works (images, video, music) for **non-commercial promotional purposes**, including online publication (e.g. on social media), public exhibitions, screenings, and media coverage.

15. Entries deemed defamatory, discriminatory, or offensive may be disqualified at the Promoter's discretion. Participants found violating competition rules or submitting false information may also be disqualified.

16. Participants shall **indemnify** the Promoter from any claims arising from a breach of these terms.

17. A **jury** appointed by the Promoter will select the **1st, 2nd, and 3rd prize winners** based on criteria such as **creativity, originality, interpretation of the theme, and artistic quality**.

18. Selected finalists will be invited to present their work at the **Embassy's Unity Day reception** in Nairobi on **3 October 2025**.

19. Participants are encouraged to share their artwork on social media using the hashtag **#BomoaUkuta2025**.
